1. General and Definitions

By registering an account or accessing this distributor portal (“Portal”), you agree to the following terms and conditions (“Terms”) governing your use. The Portal is provided by **Lifts All AB**, reg. no. 556208-4656, with registered office in Järfälla, Sweden (“Company”), and is intended solely for distributors of the Company’s products (“Distributor”).

2. Access and Account Security

Access is granted by the Company and is limited to authorized representatives of the Distributor. Login credentials are personal and must not be shared.

The Distributor is responsible for all activity on its account and must notify the Company immediately of any unauthorized use.

The Company may suspend or terminate access at any time for breach of these Terms or suspected misuse.

3. Confidentiality

All Portal content is confidential, including but not limited to:

- Price lists and discount rates,
- Technical drawings, CAD files and specifications
- Product documentation
- Internal guidelines.

Information may only be used to sell the Company’s products and may not be distributed or published without prior written consent.

Marketing materials derived from the Portal, including but not limited to product images, drawings, logos, brochures, and digital presentations, may only be modified with the Company’s written

approval. The Distributor must submit the material to the Company for review before publication or distribution.

Confidentiality obligations survive the termination of the distributor relationship.

4. Intellectual Property

All intellectual property rights in the Portal belong to the Company. Access grants a limited, non-exclusive, non-transferable license.

Materials provided by the Company or via the Portal may not:

- Be publicly published
- Be modified or altered
- Be copied for purposes other than customer-related projects
- Be used to develop, manufacture, or market competing products

5. Pricing, Orders, and Information

Prices shown are net, excluding VAT, unless otherwise stated, and are indicative. They do not constitute a binding offer. Prices are typically reviewed and updated once per year.

Orders are binding only once confirmed in writing by the Company. The Company reserves the right to update prices, specifications, and information at any time without prior notice and is not responsible for typographical or technical errors.

6. IT Security

Distributors must:

- Safeguard login credentials,
- Not attempt to bypass Portal security
- Report suspected incidents immediately
- Notify the Company of terminations immediately

Unauthorized access or hacking attempts may result in immediate suspension.

7. Limitation of Liability

The Portal is provided “as is”. The Company makes no guarantees regarding availability or error-free operation.

The Company is not liable for indirect damages, consequential damages, or data loss damages arising from Portal use.

8. Personal Data

Any personal data processed through the Portal is handled in accordance with applicable data protection laws. See the Company’s privacy policy for details.

9. Termination

The Company may immediately suspend or terminate access for breach of these Terms or upon termination of the distributor agreement.

Upon termination, the Distributor must cease using the Portal and, on request, delete or return all materials provided by the Portal or the Company.

10. Changes to Terms

The Company may update these Terms at any time. Updated Terms will apply from the date of publication on the Portal. Continued use of the Portal after such changes constitutes the Reseller’s acceptance of the updated Terms.
